## **Product description**

This is a two component amine cured epoxy coating. This product is LEED compliant and contains no solvents on the Hazardous Air Pollutants (HAPs) list. It is a fast drying, micaceous iron oxide (MIO) pigmented, high solids, high build product. Specially designed for new construction where fast dry to handle and over coating times are required. Can be used as primer, mid coat, finish coat or as single coat system in atmospheric environments. Suitable for properly prepared carbon steel, stainless steel, aluminium and concrete substrates. It can be applied at sub zero surface temperatures.

#### **Typical use**

Suitable for structural steel and piping to be exposed to highly corrosive environments, C5I or C5M (ISO 12944-2). Recommended for offshore environments, refineries, power plants, bridges, buildings and mining equipment.

Surface (touch) dry: The state of drying when slight pressure with a finger does not leave an imprint or reveal tackiness.

Walk-on-dry: Minimum time before the coating can tolerate normal foot traffic without permanent marks, imprints or other physical damage.

Dry to over coat, minimum: The shortest time allowed before the next coat can be applied.

Dried/cured for service: Minimum time before the coating can be permanently exposed to the intended environment/medium.
